Inappropriate behavior is not permitted and includes but is not limited to: harassment of any kind to other participants or staff members; conduct endangering the life, safety, health or well-being of self or others; loitering, smoking, solicitation, or panhandling; destruction or theft of equipment, supplies, or members' property; use of abusive, insulting, obscene, discriminatory or racially derogatory language; inappropriate clothing, footwear, appearance, and/or hygiene; use of the building beyond established hours of operation without prior authorization by the Center Director; or failure to follow an agency policy or procedure. If a caregiver accompanies a participant at EAMC, he/she must remain with participant at all times. All participants must obey all federal, state, county and city laws and ordinances. A participant who violates this Code of Conduct may be asked to leave the center and the EAMC reserves the right to suspend or terminate a violator's membership.
